# **SOCIETY OF FLEET SUPERVISORS HISTORY**

In June of 1945, 25 men from various segments of industry met at the Kingsbridge Armory in the Bronx for a week of training to learn how to deal with equipment and the men who operate and repair it. At the end of the week, a decision was made to continue to meet with the intent of exchanging ideas.

In September of 1945 the SFS was born. Our first President was Ed Terhume of Socony Oil, Ray Connolly of Third Avenue Transit as Vice President, and the office of Secretary, was filled by Tom Berk, the Safety Director of Met Life. The first meeting was held in a room provided by UPS and later moved to the Presidential Cafeteria in Manhattan.

Our earliest meetings saw the need for establishing committees and quickly set up Arrangements, Membership, Constitution and Programs. It was imperative, at this point, to have had formal training in fleet management through one of many schools before an application would be entertained. This one item severely limited Membership and was soon rescinded.

Initiation fees and Membership dues of \$10.00 and \$6.00 soon required the need for a Treasurer. Our first was Phillip Albo who was a Night Supervisor for Francis H. Leggiti & Co.

During our first year, a suitable insignia was developed; the wheel. It was chosen very specifically.

Christmas parties have been with us from the beginning. The very first was held in the home of Bart Amendola of Macy's but as we grew, it was moved to hotels in Manhattan, Howard Johnson's in Rego Park, and later to Eisenhower Park.

June picnics were also decided in the beginning and our founders visited Plattsdeutsch Park, Montauk and the Catskills.

Membership was always a problem gave birth to the Associate Member. They were, and do remain today, our "missionaries in the field" spreading the word and our goals.

Our second President was Ray Connolly, but little is known from here on through the early 70's except the names of our past Presidents.

# CONSTITUTION

## Article I

This Society shall be known as the Society of Fleet Supervisors, Inc. of New York

## Article II

### Objective and Aims

To promote efficient fleet operation through the exchange of ideas and experiences in the selection and training of personnel, supervisory technique, maintenance, production, safety, labor relations, plant layouts, supplies and equipment, insurance and other related subjects; to improve Members' prestige and image through training, education, public relations, projects and exposure to all facets of transportation.

## Article III

1. The Membership of the Society shall be composed of (7) seven grades; Member, Associate, Honorary, Life, Apprentice Fleet Supervisor, Student Fleet Supervisor and Original Equipment Manufacturer (OEM). (Amended 5/18/16)

1A. Member Grade: for the purpose of eligibility to run for President: Member, Associate Member and Life Members. An Associate Member must have served at least five years on the Executive Board to be eligible to run for President. (Amended 5/16/12)

1B. Member Grade: for the purpose of eligibility to vote, determine percentage of Associate/Member Ratio, Member grade will include Member, Life Member and Apprentice Fleet Supervisor. (Amended 5/18/16)

2. **Member:** those actively engaged in the direction, supervision, control, operation, maintenance, of a fleet of motor vehicles; such as a Fleet Maintenance Supervisor, Director of Operations, Director of Fleet Safety or Fleet Safety Engineer and/or Specialists, Consultant (service only) or those solely responsible for service of vehicles within a factory branch or a bonafide factory distributor not actively participating in sales. Any person who is an owner of vehicles in a fleet operation cannot qualify as a Member.

2A. **Associate:** shall include those who offer and contribute either service, information, materials or parts through sales to the transportation industry and related services. It shall be noted that the company not the individual is the member. In the event that an individual representing an Associate Member is elected President and leaves their company while their term is active, that individual shall be permitted to continue serve to the end of their term. (Amended 5/19/10)

2B. (Deleted 5/16/12)

2C. **Honorary:** Associate Members whose representative has at least (15) fifteen years Membership and has completely retired from active participation in business may be voted to Honorary Membership in the Society. (Amended 5/16/07)

2D. **Life:** Members who have completed over (20) twenty years active participation in the Society and retired may be voted to Life Membership in the Society.

2E. **Apprentice Fleet Supervisor:** shall include those actively engaged in the maintenance and repair of motor vehicles at the fleet level and not actively participating in sales. This grade shall come under the same guidelines as Member grade. (Amended 5/20/15)

2F. **Original Equipment Manufacturer (OEM):** shall include those companies which produce the product, not a distributor or dealer. It shall be noted that the company is the Member, not the individual. (Added 5/17/95)

2G. **Student Fleet Supervisor:** shall include those that are bona fide students enrolled in an accredited undergraduate, graduate or vocational program specializing in the automotive industry. The student must maintain a passing grade for the required course curriculum to remain a Student Member in good standing. Grade transcripts shall be reviewed at the end of each semester. The number of Student Members shall be limited to (20) twenty percent of Member grade. This grade shall come under the same guidelines as a Member grade except for the purpose to run for office, vote or affect the Member/Associate Member ratio. Student Membership in the Society limited to one year after graduation or upon termination of studies without graduation. The Student Fleet Supervisor may request a transfer to any other grade of Membership he/she is qualified for upon graduation or termination of studies. (Amended 5/19/09)

3. A fleet shall be composed of at least (5) five vehicles.

3A. Membership from any one organization shall be limited as follows:  
Less than (35) thirty five vehicles - (1) one Member; (35) thirty five to (70) seventy vehicles - (2) two Members; (71) seventy one or more - (3) three Members.

3B. In the case of a large company where there are (2) two or more centers of operation: each center shall be permitted to have Membership in accordance with 3A.

4. Associate Membership will be limited to (33%) thirty three percent of the aggregate sum of Member and Apprentice Fleet Supervisor grades. (Amended 5/20/15)

4A. Associate Membership limited to (1) one representative from any organization. (Amended 5/17/95)

5. OEM Membership shall be limited to (1) one representative from any organization. (Added 5/17/95)

## **Article IV**

1. The Officers of the Society of Fleet Supervisors shall be: President, First Vice President, Second Vice President, Secretary and Treasurer.

2. The above Officers shall be elected at the May meeting.

3. The Executive Committee shall consist of the "Officers" and Chairpersons of the Standing Committees and (2) "two" Past "Presidents" in attendance. (Amended 5/17/95)

4. At all Executive Committee meetings, the "Officers" shall have (1) one vote each. The Chairpersons of the standing committees shall have (1) one vote each. The "President" shall have the "deciding" vote in case of a tie. (Amended 5/17/95)

## **Article V**

1. Business meetings of the Society and Executive Committee, and other committees shall be held as advised by the Bylaws. There shall be no attempt at Executive Board or regular meetings to solicit, sell or advertise products or services.

## **Article VI**

1. The finances of the Society shall be derived from dues and other sources as may be approved by the Executive Committee.

## **Article VII**

1. The Society shall make such Bylaws, as it may deem necessary for the proper conduct of the Society.

## **Article VIII**

1. The Constitution may be amended at the May meeting by a (2/3) two thirds vote and/or voting by proxy of the Member and Apprentice Fleet Supervisor grades. Any proposed change must be submitted by the March meeting. The proposed amendment shall be read at the April meeting and written notice of said amendment shall be mailed to every eligible voting Member and Apprentice Fleet Supervisor (15) fifteen days in advance of the May meeting. Only a Member of Member grade in good standing may submit an Article change proposal. (Amended 5/20/15)

## **Article IX**

1. The full voting powers shall be vested in the Member grade of the Society. The Associate grade Member shall have (1) one vote at a regular meeting only, but shall have no vote at the May meeting or in the election of Officers of the Society. The Apprentice Fleet Supervisor shall have no vote at any meeting or in the election of Officers of the Society, as so defined by the Bylaws VI Elections, par. #6. (Amended 5/19/93)

## **Article X**

1. All Members in time of hardship will be dealt with equally. The Executive Committee, under the President, shall be the final interpreter and make available a sum of (\$250.00) two hundred fifty dollars. In addition any Member who becomes disabled or cannot work due to physical condition can have his/her dues deferred for the length of his/her disability, but the dues deferment is to be reviewed by the Executive Committee yearly.

# **BYLAWS**

## **Bylaw I Membership**

1. This Committee consisting of a Chairperson and (4) four Members determine the qualifications of the applicant for Membership in the Society.

This Committee shall meet to consider all new applicants and reclassification of present Members. A minimum of (3) three Members shall be in attendance at such meeting before action can be taken.

The Chairperson of this Committee shall obtain information pertinent to the qualifications of all applicants from (3) three references, (1) one of whom shall be the sponsor. Any Member who shall be subject to review for reclassification shall be notified in writing by the Chairperson of the Membership Committee prior to any presentation to the full Membership. He shall have the right to present his/her facts before the Membership Committee as well as the Executive Committee. When all information is obtained and considered, the recommendation of this Committee shall then be submitted to the Executive Committee for action. Following this, acceptance and grade of Membership shall be presented at a regular meeting for action by Members.

2. Any delinquent Member may be dropped. Any Member may be dropped for unbecoming conduct, upon vote of (2/3) two thirds of the entire Executive Committee, but only after the charges against said Member have been formally preferred, sent to him in writing and an opportunity to be heard thereon has been granted.

3. Effective January 1, 1977, any Member who changes job classification shall be subject to review by the Membership Committee. A Member who has worked in a Fleet Supervisors capacity for at least (20) twenty or more years shall not be subject to re-classification. Any change in Membership will become effective the following fiscal year and said Member will be subject to the dues as solicited in bylaw ix dues for that classification.

The Associate Member has the right to have a substitute represent him/her at any regular meetings during the year. The substitute must be employed by the same company as the Associate. (Amended 5/15/13)

4. When an Associate Member resigns from the Society, the company for which that person works is likewise removed from the roster. The Executive Board, may, however, extend the courtesy to the company to suggest a replacement for the former Member. The new candidate must fill out an application and meet all requirements for Membership. In the event that the Executive Board approves the new Member, that person will be admitted to the Society immediately, avoiding being placed on a waiting list for Membership. This will not affect the ration of our Membership.

5A. Former Associate Members who have resigned or had their membership terminated shall be excluded from attending regular meetings. Former Members may request reinstatement as per current membership requirements, subject to approval by the Executive Board. (Added 5/17/06)

5. The Associate Members' dues will include a monthly Newsletter advertisement, a full page ad in the Journal and a Golf Outing hole sponsorship. (Added 5/17/95)

6A. For those Associate Members joining after June, their dues shall include a full-page ad in the Journal and (1/2) one half year (5 issues) of monthly Newsletter advertisements. (Added 5/15/96)

7. The OEM Members' dues will include a monthly Newsletter advertisement, a full-page ad in the Journal and a Golf Outing hole sponsorship (Amended 5/17/00)

7A. For those OEM Members joining after June, their dues shall include a full-page ad in the Journal and (1/2) one half year (5 issues) of monthly Newsletter advertisements.

8. Life Members will be able to attend the regular monthly meetings at a nominal charge to be set by a consensus of the Executive Committee as required for economic reasons. If any Life Member expresses financial difficulty with that set price, the Society will defray the cost of that member's dinner on an as needed basis. (Amended 5/18/16)

## **Bylaw II Duties of Officers**

1. The executive power in the Society is vested in the President, who shall preside at all meetings. He shall have the power to call special meetings of the Committees or the Society at his/her discretion. With the approval of the majority of the other Members of the Executive

Committee, he shall appoint Officers to fill vacancies until the May meeting. He shall be ex-officio Member of all Committees and shall have general supervision of all activities.

2. The First Vice President shall perform the duties of the President in his/her absence or when requested by him to do so. The Second Vice President shall perform the duties of the First Vice President and for the Secretary in his/her absence or as requested by the President.

3. The Secretary shall record the minutes of all minutes of the Society, conduct all correspondence and perform all duties incidental to his/her office. He/she is obligated to turn over all records and minutes of the office of Secretary to the incoming elected President at the time of his/her installation.

4. The Treasurer shall receive, acknowledge and deposit all funds and sign all checks and contracts authorized by the Executive Committee. He shall submit a monthly statement at the monthly meeting. He shall, at the May meeting submit an audited report of the funds of the Society for the year expiring April 30.

### **Bylaw III Executive Committee**

1. The Executive Committee shall meet prior to each regular and annual meeting.

2. All Committee Chairpersons must report at the Executive and regular meeting and make annual reports.

3. Any Member of the Executive Committee absent from (4) four monthly meetings of the Committee without notification or a satisfactory excuse shall thereby cease to be a Member of the Committee.

4. The Executive Committee shall establish the "Standing" Committees and Special Committees as shall be necessary to conduct the affairs of the Society. The "Chairperson" on all Committees shall be chosen by the "President" of the Society. The Members of the Committee shall be chosen by the "Committee Chairperson" with the approval of the "President" of the Society. The Chairperson will announce the names of the persons on his/her Committee at the September Membership meeting. (Amended 5/17/95)

5. A Member may not serve as Chairperson or Member of more than (1) one Committee at a time. This is to actively involve more Members in Society functions.

6. The Executive Committee, headed by the President, shall be the final interpretation of all bylaws governing the Society of Fleet Supervisors.

### **Bylaw IV Duties of Standing Committees**

**Membership:** This Committee consisting of a Chairperson and (4) four Members shall determine the qualifications of the applicant for Membership in the Society.

This Committee shall meet to consider all new applicants and reclassification of present Members. A minimum of (3) three Members of the committee shall be in attendance at such meeting before action can be taken.

The Chairperson of this Committee shall obtain, in writing information pertinent to the qualifications of all applicants from (3) three references, one of whom shall be the sponsor. Any Member who shall be subject to review for reclassification shall be notified in writing by the chairperson of the Membership Committee prior to any presentation to the full Membership. He shall have the right to present his/her facts before the Membership Committee as well as the Executive Committee. When all information is obtained and considered, the recommendation of this committee shall then be

submitted to the Executive Committee for action. Following this, acceptance and grade of Membership shall be presented at regular meeting for action by Members.

The Chairperson shall issue new Members upon acceptance at a monthly meeting, a copy of the Constitution and the Bylaws, the Society pin and Certificate of Membership.

**Special Activities:** This Committee Consisting of a Chairperson and (3) three or more Members shall report on all special activities, special events and entertainment for the Society. Records pertaining to function attendance and moneys received or expended shall be recorded on a computer system with a printout of the final cost available to the Executive Board.

**Programs:** This Committee, consisting of a Chairperson and (2) two Members, shall arrange in advance and engage speakers to present topics, interesting and instructive, for each regular meeting.

**Arrangements:** This committee, consisting of a Chairperson and (2) two Members, shall make all arrangements for the meeting place of the Society.

**Bylaws:** This Committee consisting of a Chairperson and (2) two or more Members shall look into the Bylaws. It will report and make known any Bylaw change submitted in writing by Membership, as per Bylaws.

**Welfare-Employment:** This Committee consisting of a Chairperson and (2) two or more Members will report on employment for Members. It will also report on Members and their family any conditions that may arise.

**Scholarship:** This Committee shall consist of a Chairperson and a minimum of (4) four Members. The Committee shall have the responsibility to interview candidates and decide who is eligible to be the recipient of any scholarship awards. At the February Executive Board meeting, the Executive Board will determine the amount and number of scholarships to be awarded that year. The decision made at the February meeting is final and cannot be changed for that year. (Amended 5/19/99)

### **HANK HASIWAR SCHOLARSHIP**

Eligibility requirements for candidates and payment schedule of funds for the Hank Hasiwar Scholarships are as follows:

1. Individuals must have completed one (1) year of training at a school of higher learning in a field of study that will help the Society perpetuate itself. (College Level Courses-the candidate has already completed fifty percent of the course of study.)

The Scholarship shall be paid directly to the school upon verification of the recipient's enrollment.

2. Individuals must be enrolled in a school of higher learning in a field of study that will help the Society perpetuate itself. (Professional/Vocational courses of shorter duration than #1 above, but no less than eight (8) months duration.)

The Scholarship shall be paid directly to the school upon verification of the recipient's enrollment and successful completion of at least fifty percent of the course.

3. Individuals who are Seniors in High School, currently enrolled in a field of study that will help the Society perpetuate itself, and are applying or have been accepted to a school of higher learning in the same field. (Professional/Vocational courses of shorter duration than #1 above, but no less than eight (8) months duration.)

The Scholarships shall be paid directly to the school upon verification of the recipient's enrollment and successful completion of at least fifty percent of the course. (Amended 5/15/13)

## **SOCIETY OF FLEET SUPERVISORS SCHOLARSHIP FUND**

These scholarships would be awarded to eligible students who are related to any Member of the Society who is in good standing and who attends at least (15) of our regular monthly meetings or Executive Board meetings during the (3) three consecutive years prior to the cutoff date of all applications, which is the November general Membership meeting. Members of the Society who have completed (20) twenty years as a Member in good standing and continue to be a Member in good standing, but have relocated to another area that prohibits his/her attending Membership meetings will still qualify for scholarship eligibility. The same will apply to Members voted Life or Honorary Membership. This change to take effect on January 1, 2005. (Amended 5/14/08)

The Members are entitled to enroll (2) two applicants if the student is their child or grandchild, or (1) one applicant if the student is his/her self, spouse, niece or nephew. In order to give a fair chance to all eligible Members, only one scholarship per family can be awarded each year. (Amended 5/19/99)

Each individual must be a high school graduate and may apply for a maximum of (2) two scholarships while enrolled in any continuing education program, undergraduate or graduate study and no more than (3) scholarships per family in less than (5) five consecutive years. (Amended 5/14/08)

When the number of eligible applicants exceeds the number of available awards, the awards will be given on a raffle basis. Whether or not a raffle procedure is required, the Recipients will be named at the December Regular Meeting, if scheduled by a consensus of the Executive Committee Members, or the subsequent January Regular Meeting. The check will be paid to the order of the school and mailed to the applicant. (Amended 5/18/16)

It will be incumbent upon the Member to provide the Executive Board and the Scholarship Committee with documentation showing the undisputed relationship of the applicant. The Chairperson of the Scholarship Committee must provide to the Executive Board a complete list of the applicants and proof of eligibility for each applicant. Any incomplete application will be rejected with no discussion. In a case where a Member applicant has previously received a scholarship(s), the Chairperson must provide to the Executive Board a list of dates and numbers of previously awarded scholarships. All this information must be provided to the Executive Board at the December Executive Board meeting and prior to the final decision. (Amended 5/19/99)

**Journal:** This Committee consisting of a Chairperson and (2) two or more Members shall be responsible for organizing and expediting the Society Journal.

**Newsletter Editor:** This Committee consisting of the Editor and (1) one Member will publish and distribute the monthly Newsletter. (Added 5/18/94)

**Data Services:** This Committee consisting of a Chairperson will collect and store any information pertaining to the roster, dues, attendance and any other information as so provided by the other standing committees. (Added 5/18/94)

**Apprentice Membership:** This Committee shall consist of a Chairperson, who is an Apprentice Fleet Supervisor, and shall be responsible for encouraging Apprentice Fleet Supervisor membership. This Chairperson shall attend all Executive Committee meetings for the purpose of disseminating information to the Apprentice Fleet Supervisor members of the Society. (Added 5/20/15)

**Golf Outing:** This Committee consisting of a Chairperson and (2) two or more Members shall report on the Golf Outing for the Society. Records pertaining to donations, moneys received or expended shall be recorded on a computer system with a printout of the final cost available to the Executive Board. (Added 5/17/06)

### **Bylaw V Meetings**

Meetings of the Society shall be held on the third Wednesday of each month. Legal holidays, June, July and August may be excepted. Eight regular monthly meetings are to be held during a year.



The seven set meetings will be held in September, October and November, January, March, April and May. A consensus of the Executive Committee shall determine if the remaining (eighth) regular meeting shall take place in December or February, based on the scheduling of the Anniversary Dinner Dance (formerly the Scholarship Awards Dinner held in December), or any other events that the Society may develop. (Amended 5/18/16)

Newly elected Officers will assume the duties of their office the third Wednesday in June. The formal installation of newly elected Officers will be held at the September regular meeting.

Executive meetings of the Society shall be held according to section III of the Bylaws. (5) Five Members of the Executive Committee shall constitute a quorum at these meetings.

The order of business at the May meeting shall be as follows:

1. Reading of the minutes
2. Report of the Secretary
3. Report of the Treasurer
4. Report of the Standing Committees
5. Report of the Special Committees
6. Report of election results
7. Report of the President

(Amended 5/16/01)

(20) Twenty Members present at a meeting of the Society shall constitute a quorum. (5) Five Members of the Executive Committee at a meeting regularly called shall constitute a quorum. The order of a business meeting shall be as follows:

1. Reading of the minutes
2. Secretary's report
3. Treasurer's report
4. Report of Standing Committees
5. Report of Special Committees
6. Unfinished business
7. New business
8. Presentation of program
9. Adjournment

## **Bylaw VI Elections**

1. The election of Officers shall be conducted at the May meeting.
2. At the March meeting, the President shall oversee the formation of a Nominating Committee. This Committee will consist of (5) five Members as follows: a Chairperson, who will be the immediate past President or a past President if the immediate past President is unable, unwilling or unavailable to accept this position for whatever reason; (2) two former Executive Board Members and (2) two full Members. The Nominating Committee Members will be chosen by the Nominating Committee Chairperson. This Committee shall prepare a slate of Officers for presentation to the regular meeting in April. Other candidates may be nominated from the floor at this time. The Secretary shall send the report of the nominations with the notice of the May meeting. To be eligible for nomination for the Office of President, any Member grade must be or have at some previous time, served as an Officer and/or Member of the Executive Committee for a full term.
3. Members may vote in person or by proxy. Proxy must be by mail, addressed to the Secretary. (Amended 5/18/05)
4. No candidate may be proposed without his/her consent.

5. Voting may be by acclamation. If there is more than (1) one candidate for office, the election for that office shall be by secret ballot. The votes shall be counted by (2) two tellers who shall be named by the chair.
6. The full voting powers shall be vested in the Member grade of the Society, as described in Article III, Paragraph 1B, defines Member Grade for the purpose of eligibility to vote, determine percentage of Associate/Member ratio, Member grade will include Member, Life Member and Apprentice Fleet Supervisor. The Associate Grade Member shall have (1) vote at the regular meeting only, but shall have no vote at the May meeting or in the election of Officers of the Society. Only those Members shall be entitled to vote whose dues are paid for the current year, as so defined by the Bylaws VI, Elections, para. #6. (Amended 5/18/16)
7. No electioneering or campaigning is to be conducted on the day of election. Should any electioneering or campaigning take place, the election shall be considered null and void.
8. Voting may commence at the opening of the meeting after the cocktail hour. (Amended 5/18/05)
9. The voting booth shall be located at an isolated area of the meeting room. Only (1) one voter at a time may approach the voting booth. At that time the voter must be checked for his or her qualification to vote, and if approved, cast their vote.
10. After the tellers have tallied the votes and the results announced, the actual votes will be confiscated by the tellers and held for (30) thirty days before being destroyed.
11. In the case of a dispute, the voting may be reviewed by either Chairperson of the Committee that has presented the slate for vote up to (30) thirty days after the elections.

## **Bylaw VII Term of Office**

1. The Officers elected at each May meeting shall hold office for (1) one year and may be eligible for re-election unless disqualified. No Officer shall be eligible to succeed himself in that office after serving (2) two terms except as Secretary and Treasurer.

## **Bylaw VIII Auditing Books**

1. The Auditing Committee of (2) two Members shall be appointed by the President at the regular April meeting. Such committee shall inspect and audit all accounts of the Society for the year expiring April 30 preceding the May meeting. The appointed Auditing Committee will also determine that no unauthorized changes occurred to the Constitution and Bylaws.

## **Bylaw IX Dues and Initiation Fee**

1. Initiation fee - (\$20.00) twenty dollars to accompany application (Amended 5/17/95)
2. Member dues - (\$50.00) fifty dollars annually (Amended 5/15/02)
3. (Deleted 5/16/12)
4. Apprentice Fleet Supervisor - Apprentice Fleet Supervisor- (\$50.00) fifty dollars annually (Amended 5/20/15)
5. Associate Member dues - (\$450.00) four hundred fifty dollars annually. (Amended 5/17/95)
6. Honorary and Life: no further dues for the life of the Member.
7. Original Equipment Manufacturer (OEM): (\$450.00) four hundred fifty dollars annually. (Amended 5/15/96)

8. Student Fleet Supervisor – Exempt from dues (Added 5/19/04)

## **Bylaw X Payment of Dues**

1. The fiscal year, for dues purposes shall be the calendar year.
2. Dues shall be payable January 1 or on notice except for the President of the Society while in office.
3. Those Members joining during the first (6) six months of any year shall pay a full current year's dues; those joining after July 1st shall pay (1/2) one half of the annual dues for the balance of the fiscal year. Any Member inducted at the November meeting would be exempt from dues for the current year. (Amended 5/19/93)
4. Any Member whose dues remain unpaid by January 31<sup>st</sup> shall be deemed delinquent and a second notice shall be mailed. All new Members' dues are due at the time of their induction to the Society. Any privileges will not be granted to any new Member until such dues are paid in full. (Amended 5/17/95)
5. The Membership Committee shall have the power to terminate Membership if the dues are not paid within (30) thirty days after a Member or an Associate is deemed delinquent.
6. Any Associate Member inducted during the November meeting would be required to pay in full the coming year's dues. (Added 5/19/99)

## **Bylaw XI Honorariums**

1. The Secretary of the Society, the News Editor of the Supervisors News, the Treasurer of the Society and the Data Services Chairperson shall receive the sum of (\$99.00) ninety-nine dollars annually. (Amended 5/17/95)
2. This honorarium will be distributed at the beginning of each fiscal year. (Amended 5/18/94)

## **Bylaw XII Amendments**

1. These Bylaws may be amended at any May meeting by a (2/3) two thirds vote and/or voting by proxy of the Member grade. Any proposed Bylaw change must be submitted in writing by the March meeting. The proposed written amendment shall be read at the April meeting and written notice of said amendment shall be mailed to every eligible voting Member (15) fifteen days in advance of the May meeting. Any Bylaws may be suspended at a regular meeting of the Society by a (2/3) two thirds vote of the Members present, for that meeting only. But no permanent alteration or amendment of any Bylaw shall be made except at the time and in the manner prescribed in the preceding paragraph. Only a Member of Member grade in good standing may submit a Bylaw change proposal. (Amended 5/17/00)

## **Bylaw XIII Annual Golf Outing Proceeds**

1. (60) Sixty percent of all proceeds from our Annual Golf Outing will be used to fund either or any of our scholarship awards and educational expenses as determined by a majority vote of our Executive Board. (Amended 5/17/00)
2. The remaining (40) forty percent will be placed into a fund and used to subsidize other events sponsored by the Society for the benefit of its Members. A consensus of the Executive Committee shall determine the event and the amount of subsidy. A consensus of the Executive Committee can also approve that all or part of this forty percent be used to augment the funds

available for the scholarship awards and educational expenses, described in Paragraph 1 above, as required. (Amended 5/18/16)

#### **Bylaw XIV Accountant Services** (Added 5/20/92)

1. The Executive Committee shall retain the services of an accountant each year at or about the January Board meeting, to file all governmental responsibilities for the Society. (Amended 5/17/06)
